#### What's in a Mission Statement?

So we take care of a lot of poor people?

Well, yes. However, many of our residents did not live their lives poor.

Some have had big medical bills for their spouse, and themselves, that have gotten their money and other assets below \$1,500, which qualifies them for Medicaid.

Regardless, we are here to serve people in need no matter what their history.
